#### WELCOME TO OUR NEW EXECUTIVE DIRECTOR

2022 was a year of major transitions for Murray Grove. Following the December 2021 resignation of Diem Jones, who had served as Executive Director for 2 years, the board hired Barbara Heisler as Interim Executive Director for 6 months, January - June 2022. Barbara came to us as an Experienced Interim Executive Leader, after working many years in the nonprofit field. She was able to clarify and update policies and procedures for the organization, facilitate staff function, simplify systems in use and facilitate this time of change.





In January the board instituted a search for the next executive director. The board selected Crystal Cassella as Murray Grove's Acting Executive Director for 6 months, June through December. Crystal is a dedicated Mother, Family-Member, and Friend with a broad and varied set of experience. She's a supporter of the Therapeutic Wellness Community Advocate for Changing the Stigma. She is a Certified Peer Recovery Specialist (CPRS), Mental Health First Aider (MHFA), and an Advocate for Mental Health Awareness: Celebrating Life and Healing using Creative Arts & Music Movement. She is a community

advocate assisting individuals through Recovery & Wellness programs to access a path towards a healthy, self-empowered life.

"Murray Grove is a hidden gem in Lacey Township; our new programs will introduce this historic and restful site to our neighbors in new ways, while continuing to serve the larger Unitarian Universalist community," Cassella said. "The legacy of kindness and love from this site will continue, and its impact spreading radical hospitality will grow stronger. I am excited to work with this board and staff in this new position."

Her professional background includes years of experience as a project coordinator, convention coordinator, customer service representative, shipping clerk, quality assurance clerk, operation/production manager, purchasing agent, inventory manager, estate manager and finally 9 months as Relationship Manager & Development Coordinator for Murray Grove in 2021.

Crystal's necessary corporate qualifications for the position with her love of Murray Grove, and a long history with the site, and a career shift into nonprofit management led to the Board voting in December 2022 to hire Crystal as the Executive Director of Murray Grove.





#### SOME OLD FAITHFULS AND SOME NEW FACES

Coming of Age Retreat was held online in March. The Murray Grove Coming of Age Enrichment Program is designed to enhance and deepen the experiences of participants in Unitarian Universalist Coming of Age classes.

**Camping in the Grove**, in its 11<sup>th</sup> year, held 2 Full Week Sessions from August 7<sup>th</sup>-August 13<sup>th</sup> and August 14<sup>th</sup>-August 20<sup>th</sup>. Our intrepid team, led by Camp Director Dana Moore and Camp Program Director Max Solomon-Frye, kept a dozen campers in our youth camp busy and safe for a fun week of discovery and joy.

# President's Message



#### A MESSAGE FROM THE PRESIDENT OF THE BOARD

Dear friends,

Greetings from Murray Grove. It is my pleasure to share encouraging news and accomplishments of 2022 from our Board of Trustees. The Pandemic brought loses we've had to endure, and societal experiences have made us reassess many of our norms while introducing new ways to conduct business.

After reorganizing in 2021, the Board decided to shift for 6 months to an Interim Executive Director, Barbara Heisler, who assisted us:

1. Living into the New Mission and Vision Statements created in 2021:

Murray Grove Vision Statement: "Building a future of justice and kindness for all."

Murray Grove Mission Statement: "Murray Grove is a retreat center inspired by the concept of radical hospitality. It serves people of diverse backgrounds both in person and on-line providing opportunities for rest, renewal, inspiration and growth. Murray Grove supports people to create a world of greater kindness and justice."

- 2. Updating many policies and procedures for the organization, facilitating staff function, simplifying systems in use and easing the staff through this time of change.
- 3. Bringing about enhanced approaches for our finances to ensure accountability and sustainability.
- 4. Helping the Board to set goals and how to move those goals into a formidable action-oriented position.
- 5. Preparing the Association for its next chapter of Executive Director.

As we entered into 2022 with a renewed focus, there were continuing challenges to decipher. With determination to help us overcome and to remedy like situations, we onboarded 2 new Board Members, **Keith Timko and Joseph Yelder**. Their knowledge and experience are helping us to steward Murray Grove.

We had an educational Homecoming to end 2022, Building for a Sustainable Future. Presenters represented Red Bank NAACP, Monmouth University, UU Faith Action, the Bayard Rustin Center for Social Justice and FAIR a high school youth organization working to end racism in school systems. The theme was "success in social justice work" representing John Murray's message to bring Justice to all our communities.

The board named *Crystal Casella* as the Acting Executive Director for 6 months, June through December, and in *December hired her* as our permanent Executive Director.

The continued Vision and Mission are the singular threads of life-changing support to those who come to Murray Grove to find respite and joy. While there is much to be thankful for in the past years of work, we want to strategically shape our future outputs and be unmatched in our educational programs for our communities.

In the middle of this New Year, as we look back visualizing the successes and forward to the challenges, we resolve to create a financially sustainable system for Murray Grove.

Your continued contributions to Murray Grove would be an asset in this area. We are thankful and excited for the work ahead of us.




